TOM BENTLEY MEMORIAL CONTINUING EDUCATION SCHOLARSHIP

Instructions and Guidelines

Please read carefully.

- I. The children or grandchildren of Volunteers, and the children or grandchildren of employees of MidSouth Community FCU are not eligible for participation in this scholarship program.
- II. ELIGIBILITY OF SCHOLARSHIP:
 - A. A member in good standing of MidSouth Community FCU.
 - B. A High School graduate or have completed the GED Requirement.
 - C. Acceptance to a regionally accredited American college, university or vocational/technical school at the time of application.
 - D. If you have caused a loss to MidSouth Community FCU in the past, you are ineligible for the scholarship program. If you are awarded a scholarship and cause a loss to the credit union during the length of the four-year funding period, your scholarship will be terminated and you will not receive any additional funds.
- III. APPLICATIONS WILL BE CONSIDERED ON THE BASIS OF THE FOLLOWING:
 - A. Need
 - B. Grades
 - C. Essay
 - D. Overall appearance of application
 - E. Recommendations written by two community leaders, (i.e. pastor, educator, business leader, etc.)
- IV. STUDENT'S RESPONSIBILITY IN APPLYING:
 - A. Hand-deliver or mail all completed application materials to the address below so that it arrives no later than 5:00 pm, Friday, April 28, 2017.
 - B. Letters of recommendation and academic transcript(s) (from any college, university or vocational/technical school you have previously attended) must be mailed to the address below and received by 5:00 pm Friday, April 28, 2017.
 - C. Mailing/hand-delivery address:

V. SCHOLARSHIP AMOUNT:

- A. One scholarship in the amount up to \$2,000 will be paid to the recipients' college, university or vocational/technical school in installments of no more than \$500 per semester.
- B. This scholarship is automatically terminated:
 - (1) should the recipient's Grade Point Average (GPA) fall below 2.50, or
 - (2) should the recipient cease to be enrolled in a college, university or vocational/technical school

Note: By August of each year, the institution must send a transcript of the recipient's grades and GPA to the credit union's Scholarship Committee before further disbursement of scholarship funds can be mailed to his/her college.
